Property Report (Duncan MacIntyre)

It is always with anticipation of whether St. Peter's has fared well through the winter as we approach returning to Stony Lake. Did any animals, especially the red squirrels get into the cottage??

I'm happy to report that the new decking was installed on the canoe dock with the help of many budding handymen. Otherwise, no major work was carried out. The small boat dock remains an area to keep an eye on of which I have reported previously.

At the 2016 Annual meeting in August, there was a discussion on any plans to accommodate persons with handicaps. A ramp was discussed as well as railings on some areas of the property. From research, the most wheelchair users can manage is a slope of 1:15 to 1:20 which rules out any ramp. The ramp would be too long! I approached the Diocese of Toronto for their guidance. Even within the Diocese there are churches where access just isn't feasible due to space

considerations and beyond economic sense. To accommodate those very rare occasions at St. Peter's, the canoe dock can be used for access. The installation of a railing will be looked into.

This will be my 8th year as Property Co-ordinator. I feel it is time to pass the torch to someone else. Please contact Senior Warden Ross Dobbin or me if you are interested. It is a very fulfilling position. I've enjoyed contributing in some small way to St. Peter's.

Treasurer's Report (Pat Bunting)


The treasurer's focus in 2016 was on expense control and donation management.

Expense Control

Expenses are managed in 5 basic categories against a 36-line monthly budget. Referencing the following table, I am pleased to report that 2016 general operating expenses were \$5.3K favourable to 2015 expenses and \$2.8K favourable to the 2016 budget, essentially attributed to lower dock repairs, outreach scaled back to traditional levels and less frequent septic pump-outs.

Based on 2016 actuals, the planned 2017 general operating budget is \$28K, subject to Select Vestry approval.

Donations Management

The revenue side of the equation for 2016 was not as encouraging. Though mailed-in donations were up \$4K (+22%), Sunday collections were down by some \$6K (-27%) over the prior year, resulting in an overall reduction in giving of 5%. Notwithstanding, the generosity of the St. Peter's community is still significant, which continues to allow us to build a reserve for unforeseen events. The 2016 contribution to the reserve was close to \$8K.

To better enable the receiving of donations, the options to give have been expanded. Please note that options 3 & 4 entail handling fees but nevertheless, use the option that works best for you.

- 1. Mail in cheque using the enclosed 2017 contribution sheet.
- 2. Utilize the provided contribution envelope at the Sunday service, either cash or cheque. If you don't use the envelope for Sunday giving, we are not able to issue a tax receipt.
- 3. Log on to CanadaHelps (www.canadahelps.org), use the search by charity key words (St Peter's on-the-Rock Lakefield). Click and go to donate now and use your credit card. CanadaHelps will directly issue a confirmation and Canadian tax receipt.
- 4. If you are based out of the United States and wish to have a US tax receipt, log on to the American Fund (www.americanfund.info), click on donate, scroll down the list of evaluated charities, select St. Peter's on-the-Rock and complete your donation.

Data Management

This year we have also implemented new fund management software which centrally manages contact information, tracks givings, enables mass e-mail or letter communication and better supports the issuing of tax receipts; you may have noticed your 2016 tax receipt now includes a record of donations, dates and cheque numbers (where a cheque was used). When using the giving envelopes, only fill out the contact information once, you just need to use your name for subsequent offerings. Similarly, if you received a 2016 tax receipt and there is no change to your contact information, you are in the system, just put your name on the envelope.

Endowment Funds

In addition to the foregoing, we are also in the process of finalizing the set-up of two Endowment Funds. The first will provide long term funding for the St. Peter's Music Scholar's program. This fund was enabled by a very significant donation from the Walter family, for which we are most grateful. The second fund is to enable St. Peter's to receive and invest bequeathed gifts (securities or cash) to help support the long term needs of the church. As we continue to see a reduction in general numbers, we see this fund as an important way of ensuring the viability of St. Peter's onthe-Rock for the generations to come.
